BOTTOM LINE UP FRONT

As a result of the June 26, 2020 Presidential Executive Order: Protecting American Monuments, memorials, and Statues and Combating Recent Criminal Activity, and your directive to DHS law enforcement components, Customs and Border Protection (CBP) and U.S. Immigration and Customs Enforcement (ICB) mobilized tactical teams to provide support to the Federal Protective Service (FPS) in protecting federal buildings and assets within the greater Portland, Oregon area. The U.S. Marshals Service deployed their Special Operations Group (USMS/SOG) to further assist FPS in the protection of the Mark O. Hatfield Federal Courthouse in Portland. The U.S. Secret Service, ICE Homeland Security Investigations (ICE/HSI) and the Federal Bureau of Investigation (FBI) have also provided investigative support to FPS.

Since the deployment of personnel by the various agencies, there have been nightly coordinated attacks against Federal Property and assaults on Federal Law Enforcement Officers. Approximately fourteen (14) individuals have been arrested on varying charges to include, 18USC111 (Assault on a Federal Officer) and 18USC1361 (Malicious Mischief) and seven (7) individuals detained, cited and released pursuant to a Central Violation Bureau tickets issued by FPS. The U.S. Attorney's Office for the District of Oregon is reviewing each case to determine appropriate federal charges for each arrest.

You will drive by the Federal Courthouse to witness the damage done to the building and meet with Federal leadership in Portland to discuss the ongoing FPS operations.

BACKGROUND

A. The current civil unrest in Portland has occurred nightly since George Floyd died on May 25, 2020. The riots that have ensued have wreaked haveo on local businesses as a result of looting and darnage as well as to federal, state and local buildings. The Mark O. Hatfield Federal Courthouse has been the main building targeted along with the Multnomah County Regional Justice Center and Portland Police Bureau (PPB) Central Precinct. However, additional buildings have been impacted as well, to include the ICE building, Edith Green-Wendell Wyatt Federal Building and PPB's North Precinct. The joint DHS operations involving targeted arrests on violent opportunists has led to a decrease in attacks against federal facilities. Social Media accounts have highlighted numerous times that destruction and defacing of federal facilities should be avoided due to the rapid response by federal officers to arrest violators.
