	Jul 20, 2026	MINUTE ORDER: The Court has reviewed the Parties' briefing on the 128 Motion to Enforce Judgment and the 131 132 Supplemental Memoranda. In light of the Northern District of Florida's grant of the Plaintiffs' Intervention Motion, there is a possibility that further proceedings in the Eleventh Circuit may moot the Court's need to address the 128 Motion to Enforce. Accordingly, the Court defers ruling on the 128 Motion to Enforce pending further proceedings in the Eleventh Circuit that may grant the Plaintiffs the relief that they seek. The Court directs the Parties to file a joint status report on July 22, 2026, and every seven days thereafter, updating the Court on the status of the appeal of Florida v. DHS, No. 3:24-cv-509 (N.D. Fla.) in the Eleventh Circuit. The Court has reviewed the Northern District of Florida's Order on the Intervention Motion and finds that no response is necessary. Signed by Judge Sparkle L.
