As I understand, the timelines are as follows:

Set on initial MC 30 days from Received Date

Set on MR 40-45 days from Received Date

Set on IC 6 months from Received date

Completed 365 days from Received date

*The Received Date being the date received by Court.

Reference Chart points out that the **Initial Hearing is within 30 days and completion within 365 days.**

In the effort to accomplish these deadlines and give all parties efficient time to prepare their case and deal with any unexpected issues.

NYC/IC has gained guidance from CA Jason Burke and DCIJ Cheng .

Estimated time frames

Initial Hearing : within 30 days

Master Reset : 40-45 days

Individual Hearing : 5/6 months from receive date (efficient time for application to be file,etc.)

However these are just estimate time frames , hearings can be completed earlier .

REQUIRED time frames

Initial Hearing: within 30 days from the filing of the NTA.

Master Reset : 40-45 days from the initial master – please ensure enough time for respondents to see counsel / get an appointment with the pro bono groups. 40 to 45 days is a solid approach. 3 weeks is not enough time to get an appointment with the pro bono groups.

CASE COMPLETIONS: MUST BE COMPLETED WITHIN 365 DAYS OF THE FILING OF THE NTA.

IF YOU CAN schedule say 5/6 months from receive date, then we are allowing sufficient time for application to be file, etc.)

JUST MAKE SURE YOU COMPLETE THE CASE WITHIN 365.

PLEASE GET THEM DONE AS SOON AS WE CAN.
