Mass migration from South America into the United States is said to be coordinated at some level by non profit organizations who wish to line their pockets with proceeds deriving from migrants transportation fees up to the U.S Mexico border, and ultimately proceeds deriving from the migrants paying for their asylum case lawyers once they have arrived to the United States. Other groups such as Antifa, have also sought the opportunity to exploit the migration crisis in order to cause chaos for the U.S. Government. Although these groups have been predominately operating in Tijuana, Mexico and San Diego California there is reporting that some may have made their way to El Paso Texas

Non profit organizations tend to take immigration lawyers to Mexico in order to meet with asylum seekers. While in Mexico lawyers promise to work on the individuals asylum case and advise the immigrants that once they are in the United States to seek their legal representation with their respective offices. Funding for these asylum cases come from go fund me accounts and aid from the non profit organizations.
